Sign Waiver

In consideration of being permitted to participate in any way, including travel to and from, **The Greatest Camp on Earth**, in any Judo, Ju-Jitsu, Wrestling, Aikido & Karate tournament, practice, clinic, and related events and activities of **United States Judo Federation, United States Judo Association, United States Judo, Inc., United States Olympic Committee, ATJA, Matthews Police Athletic League, & CAJA (Carolinas American Judo Assn.)**:


1. I acknowledge that I am familiar with the sport of Judo, Ju-Jitsu, Wrestling, Aikido & Karate and understand the rules governing them.
2. I agree that, prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
3. I acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, to the rules of the sport of Judo, or to conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, Ju-Jitsu, Wrestling, Aikido & Karate, I assume all such risks and accept personal responsibility for the damages following such injury, permanent disability, or death.
5. I release, waive, discharge and covenant not to sue United States Judo Federation, United States Judo Association, United States Judo, Inc., United States Olympic Committee, ATJA, Matthews Police Athletic League, CAJA (Carolinas American Judo Assn.), together with their affiliated clubs, their respective administrators, directors, agents, coaches and other employees or volunteers of the organization, event officials, medical personnel, other participants, their parents, guardians, supervisors and coaches, sponsoring agencies, sponsors, advertisers, and if applicable, owners, lessors, and lessees of premises used to conduct the event, all of whom are hereinafter referred to as "releasee", from any and all claims, demands, losses, or damages on account of Injury, including permanent disability and death and damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise to the fullest extent permitted by law.
6. I understand that persons and activities may be photographed during Camp by Camp personnel, both on and off premises; and I agree that the resultant images may be used, sold, published, given away, or reproduced without limit and without payment, notice, or obligation of any kind.
